Hope everyone had an enjoyable Christmas and the New Year is upon us. Thanks to all those who have participated in ARES/RACES nets and events this past year. Looking forward to 2019. We need to reflect and see where we can improve, self included, to exam what are the core needs of the the agencies we serve, what do they expect from our group?

Here what's been going on, during the past few weeks;

Participants of the ARES/RACS NET, that have been practicing FLDIGI, have been re-joined by Ivan, N1OXA. He is back online with the capability. Join us Thursday evenings, after the voice portion of the NET. We have sometimes used the repeater for voice while we do FLDIGI on HF. That way we can explain to each other (on VHF) how and why to set up FLDIGI for HF. It is different than going through the repeater, and really expands your knowledge of operating this digital mode.

I recently received a e-mail, via WinLink, from Steve KB1TCE, in which he was discussing RADIOGRAMS, and FLMSG (from FLDIGI). He, Steve, noted that FLMSG files (.k2s object files) can be opened from WinLink without having to detach and save the FLMSG. I need to explore this further to see exactly how that works. Could this lead to a seamless message traffic handling from FLDIGI to WinLink? Cool, have to check it out. If anyone else has tried this, let me know.

Maine Packet Network has grown. 9600 is being worked on. Presently operating at a slower rate, it's up and running. BPQ32 Node N1ZRL-15, Lisbon Falls, is part of that effort. Connect and see what and where you can go. (I am not an expert, still leaning.)
